Contract also provides associated technical support and maintenance. DEN is obligated per the Denver/Adams County Intergovernmental Agreement on a New Airport to continuously maintain an operating noise monitoring system.

Cost/value: \$1,078,180 – covers 3-year base term, two optional 1-year extensions, and Additional Services. Contract provides enhanced value as compared to present contract with existing vendor as it reduces annual cost and provides a more capable product.
