10 **For an ordinance establishing a new fund in the General Government Special**
11 **Revenue fund and making rescissions, cash transfers and supplemental**
12 **appropriations from the General Contingency Fund to the General Government**
13 **Special Revenue Fund.**

15 **WHEREAS**, the creation and establishment of a Tourism Improvement District proposed on
16 the November 7, 2017 election passed, and

17 **WHEREAS**, a portion of the revenue collected from the approved 1% tax levy on the
18 purchase of lodging within the Tourism Improvement District will be used for tourism marketing
19 and promotion efforts;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
21 **DENVER:**

22 **Section 1.** A new fund is hereby established in the General Government Special Revenue
23 Fund, Accounting No. 11000, a “Tourism Improvement District (TID) Marketing and Promotion
24 Fund”, Accounting No. 11868 for the purpose of accounting for the receipt and expenditure of tax
25 levy dollars related to tourism marketing and promotion

26 **Section 2.** Monies received from TID tax levies, interest, and other sources of revenue
27 including transfers from other City funds, shall be deposited into the Treasury of the City and
28 credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the
29 Revised Municipal Code of the City and County of Denver.

30 **Section 3.** Expenditures are hereby authorized for the Tourism Improvement District
31 Marketing and Promotion Fund”, Accounting No. 11868 as appropriated in Denver’s Annual
32 Appropriating Ordinance and other ordinances making appropriations or rescissions in said fund
33 for the purpose described in Section 1 of this ordinance, to be expended by the Chief Financial
34 Officer. Allowable expenditures include but are not limited to tourism marketing and promotion,
35 and cash transfers for the same purpose as described in section 1. This is an appropriated, non-
36 lapsing fund.

1 **Section 4.** From appropriations heretofore made from the General Fund listed or indicated in
 2 the following tabulation there is hereby RESCINDED the amount listed or indicated in such
 3 tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

 12 accounts hereinafter designated the amount of money following such designation, to be expended
 13 for the purposes and upon the authorizations in said Ordinance set forth:

 24 supplemental appropriations or rescissions, there is hereby appropriated to the appropriation
 25 account to be expended for the purposes and upon the authorizations in said ordinance set forth:
