## **A BILL**

For an ordinance making an appropriation from the General Government Special Revenue Fund.

WHEREAS, the City of Denver has a revenue sharing agreement with Denver Public Schools that allows the City to transfer an amount equivalent to what would be paid from the Convention Center Hotel in property taxes to DPS (the Hotel currently pays a Payment in Lieu of Taxes instead of property taxes); and

**WHEREAS**, for 2011 DPS is eligible to receive \$31,000 more than the estimated transfer in the current appropriation;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

**Section 1.** From the General Government Special Revenue Fund, Accounting No. 11000, out of monies not otherwise appropriated and in addition to the amounts heretofore appropriated by Ordinance No. 623, Series of 2010, and any supplemental appropriations or rescissions there is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

The foregoing appropriation is to transfer funds to Denver Public Schools.

**Section 2.** The Manager of Finance of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
