10	Internal Service No. 66100, to administer the City's self-insurance program; and			
11	WHEREAS, said ordinance established that the Fund would be appropriated, and the			
12	Fund's annual budget would be established in the Annual Appropriation Ordinance; and			
13	WHEREAS, the Medical Self Insurance program funds employee medical payments for			
14	participants who elect this benefit, and funds can only be used for this purpose; and			
15	WHEREAS, the primary revenue to this Fund is City and employee premium contributions			
16	and is based on the number of employees participating in this plan; and			
17	WHEREAS, the annual appropriations, including in 2023, to pay claims have fallen short of			
18	the cash balance in the fund (note, the fund has enough cash and reserves to pay claims, but has			
19	insufficient appropriation); and			
20	WHEREAS, this ordinance seeks to amend the Medical Self Insurance Fund, from			
21	appropriated to revenue-based to align the budget with program revenue received and			
22	retroactively ratifies the 2023 appropriations needed, which 2023 appropriation was originally			
23	made by Ordinance No. 1446, series of 2022;
