This is a housekeeping amendment related to implementation of one of the "G2" charter amendments adopted by the voters on November 5, 2013. One of the charter amendments in 2013 allowed the Manager of Aviation to appoint up to five executive level employees outside of the Career Service System to serve at the pleasure of the Manager. However, the provision of the D.R.M.C. that regulates the compensation of non-uniformed employees who are exempted from the Career Service was never amended to reflect this new group of at-will appointees. The proposed bill will correct this oversight.
