A BILL

For an ordinance approving and providing for the execution of a proposed amendment to the Grant Agreement between the City and County of Denver and the Greenway Foundation concerning the "Phase I River Vision Implementation Plan" project and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the City and County of Denver and the Greenway Foundation, in the words and figures contained and set forth in that form of Grant Agreement available in the office and on the webpage of City Council, and to be filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, under City Clerk's Filing No. 2013-0249-A, is hereby approved.

Section 2. The payments made by the Greenway Foundation to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said project is as follows:
