6 **For an ordinance approving the execution of a Sewer Use and Drainage Permit by**  
7 **the City and County of Denver to provide sanitary sewer and/or wastewater**  
8 **services to property located outside City limits.**

10 **WHEREAS**, the proposed Sewer Use and Drainage Permit by the City and County of Denver,  
11 cannot be executed by the proper officials of the City and County of Denver until after approval action  
12 or inaction by the Council of the City in accordance with Subsection 56-97(a)(4) of the Revised  
13 Municipal Code of the City, because the Sewer Use and Drainage Permit provides for the carriage of  
14 wastewater of a person or entity outside the geographical limits of the City with respect to a property  
15 located at 5270 North Fox Street, Adams County, Colorado; and

16 **WHEREAS**, the City has duly reviewed the proposed Sewer Use and Drainage Permit;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
18 **DENVER:**

19 **Section 1.** The proposed Sewer Use and Drainage Permit by the City and County of Denver,  
20 in the words and figures contained and set forth in the form of Sewer Use and Drainage Permit filed in  
21 the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, under City  
22 Clerk's Filing No. 20240059 is hereby approved.
