The current outdoor pool at the Swansea Recreation Center is at the end of its useful life and the existing facility is unable to accommodate the community in its present size and state. The goal of the project is to replace the outdoor pool with an indoor pool that the community can utilize year-round, correct ADA non-compliance issues where new work and renovation occurs and construct a facility within the City's budget as defined by the Elevate Denver Bond.

This contract with FCI CONSTRUCTORS, INC. is for the construction phase of the CM/GC project.

- The CM/GC's services during the Construction phase of the project include, but are not limited to, construction management, administration, field supervision, coordinating subcontractors, maintaining quality, meeting schedules and providing the general conditions work for the Project.
- Generally, all trade contracts shall be competitively bid and assigned to the CM/GC's contract; however, when circumstances warrant it, the CM/GC will be allowed to self-perform work. This work shall be competitively bid by the GC against other contractors performing the same scope of work and the CM/GC's bid will be submitted to the DOTI PM in a sealed envelope or via email no later than 24-hours prior to other bidders.
- The CM/GC shall implement and maintain a project controls system with full access to the project information by all project stakeholders.
