This request is to update the ordinance authorizing expenditures within fund 38246 – Summit Lake Park Collections – housed within the Department of Parks and Recreation.

The current ordinance authorizes expenditures on capital items; the proposed updated language would permit expenditures on operational and maintenance items at Summit Lake and Echo Lake, too.

In addition, the ordinance's current language stipulates that revenues from this fund are derived from USDA Forest Service Fee collection. Because of the recent adoption of a \$5.00 City fee for access to Summit Lake, the language determining the source of revenues will be expanded to state more generally: "revenue generated at Summit Lake and Echo Lake."
