

**AMENDMENT TO LEASE AGREEMENT**

**THIS AMENDMENT TO LEASE AGREEMENT (“Amendment”)** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **HOUSING AUTHORITY OF THE CITY AND COUNTY OF DENVER**, a quasi-municipal corporation of the State of Colorado (“Lessee”) (collectively “Parties”).

**WITNESSETH:**

**WHEREAS**, the Parties entered into a Lease Agreement dated June 27, 2014 (the “Lease”) whereby the City leased to Lessee a building commonly known as the Neighborhood House located at 1265 Mariposa Street in the City and County of Denver, Colorado; and

**WHEREAS**, the Parties wish to extend the Term for an additional five (5) years.

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

1. **Capitalized Terms**: Capitalized terms herein shall have the same meaning as is ascribed to such terms in the Lease, unless otherwise defined herein.

2. **Term**: Section 2(A) of the Lease, entitled “Term”, is amended to provide that the Term of the Lease is extended to include August 1, 2019 through July 31, 2024 (“**Extended Term**”).

3. **Rent**: Section 3(A.) of the Lease, entitled “Rent”, is amended to additionally provide that Lessee shall pay to the City the annual rent for the Extended Term of one dollar (\$1.00), for a full amount of five dollars (\$5.00) which shall be delivered to Division of Real Estate within ten (10) days following the effective date of this Amendment. The total amount of Rent during the entire Term of the Lease is ten dollars (\$10.00).

4. Notices: Section 27 is hereby deleted in its entirety and replaced with the following:

5. Ratification: Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

6. Effective Date: This Amendment will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.

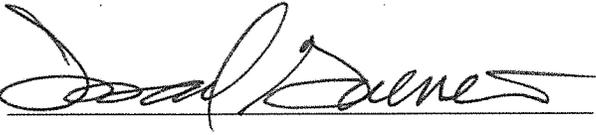
