5 **To set a public hearing on Service Plans for the formation and establishment of**  
6 **six (6) Title 32 Districts: The River Mile Metropolitan District No. 1; The River**

8 **River Mile Metropolitan District No. 4; The River Mile Metropolitan District No. 5;**  
9 **The River Mile Platte Valley Metropolitan District.**
