**5. General description or background of proposed request. Attach executive summary if more space needed:**

It is in the best interests of the Department of Transportation and Infrastructure and the City at large to extend these contracts beyond the standard three (3) years. All of these on-call agreements were procured together and awarded at the same time.

This proposal has been reviewed and approved by the DOTI Procurement Committee.

The vendors that have been providing on-call architectural services for The City and County of Denver have been performing well and provide an important resource for the City to implement design and construction projects. The current contract durations for the architectural on-call vendors are set to expire on 6/30/2021. Under analysis of the remaining capacity of the current contracts, it is recommended to extend these on-call contracts for an additional 2-year term for a time only basis. The reasoning for the time-only extension include: economic uncertainty in the mid-term making re-procurement scope unclear, current capacity of the on-call contracts projected to be adequate to cover needs for next two years, and current firms are well performing and progressing toward meeting DSBO goals. Formal procurement for the architectural on-calls will be set to issue new contracts once the extended contracts expire on 6/30/2023. The combination of factors listed above provides the justification for this exception to XO 8.
