EXECUTIVE SUMMARY

The Denver 14th Street General Improvement District (GID) is a Title 31 Special District created by the City in 2009. The Denver City Council is the Board of Directors of the GID. The GID and the City entered into an Intergovernmental Agreement (IGA) dated March 30, 2010 that established the procedure for paying for and constructing certain Improvements along 14th Street downtown as part of the City's Better Denver Bond 14th Street Streetscape Project. The City and the GID desire to amend the IGA through this First Amendment to provide for the payment of additional monies from the GID to the City for construction of additional improvements as part of the Better Denver Bond 14th Street Streetscape. Such additional projects may be initiated by the District Advisory Board submitting a (new) scope of work and cost estimate for such additional project(s). The Manager of Public Works shall review any New Scope of Work and costs and if acceptable, the District shall pay the City for all of the costs related to the New Scope of Work. The GID will in turn enter into agreements with individual property owners seeking to have such additional work performed whereby the additional work will be agreed to and funding for such work will be paid by the owner to the GID. The GID will then pay the City. Upon receipt of such payment, the Manager will initiate a change order with the contractor or otherwise work to complete the New Scope of Work. This Resolution by the GID Board of Directors authorizes the GID to execute the First Amendment.
