I am writing to express YIMBY Denver's support for the rezoning of 4340 S Monaco St. to allow for the conversion of this property from underutilized offices into desperately needed affordable housing.

Denver faces a shortage of some 70,000 housing units. This shortage has made housing much less affordable in Denver, and increasingly is contributing to labor shortages as fewer workers move into Denver due to the lack of affordability.

The proposed project at 4340 S Monaco St. is a great example of the type of development we need much more of if Denver's housing shortage is ever to ease. The project offers 100% affordable housing, at an average of 60% of AMI, and offers a range of unit sizes all the way up to 4 bedrooms, a rarity on the rental market.

As an office-to-residential conversion project, it makes use of an existing structure, and could be a demonstration of how other office-to-residential projects could work in the future.

We urge you to approve this rezoning on June 17th without delay.
