CWEE provides career readiness and case management services to low-income Denver families who receive assistance through the Temporary Assistance to Needy Families program. Funding from the Health Foods for Denver's Kids (HFDK) program expands the variety and abundance of healthy, culturally appropriate food choices in CWEE's on-site pantry available to career seekers. The HFDK program also funds onsite enrollment assistance for federal aid programs, quarterly healthy cooking classes, and a summer food box distribution program to supplement family diets while schools are out of session.
