RR13-0697 Approves the Mayoral appointment of Sarah Daily to the Denver Preschool Program Board of Directors for a term effective immediately and expiring March 12, 2015, or until a successor is duly appointed.

#### B. <u>City Council - Steven Hutt</u>

- BR13-0687 Approves amendments to the DERP governing ordinance in order to remove obsolete language, clarify the intent of certain existing language, and bring existing Code language into precise conformance with various long-standing administrative practices of the Plan.
- BR13-0688 Re-sets the total Actuarially Required Contribution (ARC) rate for the Denver Employees Retirement Plan (DERP) to 18.5% of pay for 2014, from the current rate of 18.0%.

not meet current U.S. national standards and/or replacement parts are not available any longer. Items to be donated include dry chemical extinguishers, hose nozzles, engine and pump adaptors, circular saws, sump pumps, pike axes, and face pieces.

- BR13-0706 Approves the purchase of a fire education mobile safety trailer in an amount not to exceed \$100,000 from 2013 appropriated funds. This trailer will replace the original trailer donated by former Councilwoman Cathy Reynolds.
- BR13-0724 Approves an amendment to the Qwest Communication, LLC contract doing business as Century Link QCC to extend the contract through June 30, 2014 and to add \$273,769 for maintenance on the city's 911 phone switches and supporting systems (CE76017-03).
