A BILL

For an ordinance naming the to-be-constructed central Denver recreation center at the corner of Colfax Avenue and Josephine Street as the “Carla Madison Recreation Center”.

WHEREAS, the City and County of Denver is in the process of designing and constructing a new central Denver recreation center at the northeast corner of Colfax Avenue and Josephine Street; and

WHEREAS, in accordance with the procedure established by the Department of Parks and Recreation’s Naming Policy, a community effort supported by the Department of Parks and Recreation was undertaken to arrive at a name for this unnamed recreation center; and

WHEREAS, a petition entitled “To Name It Carla” with over 1000 signatures along with numerous letters and emails supporting the naming of the recreation center for Carla Madison, a former City Council member, was received by the Department of Parks and Recreation; and

WHEREAS, the proposed naming is in accordance with the Naming Policy; and

WHEREAS, the Executive Director of the Department of Parks and Recreation supports the proposed naming of this park, and the Denver Parks and Recreation Advisory Board voted at its meeting on October 8, 2015, to recommend the naming of the to-be-constructed central Denver recreation center as “Carla Madison Recreation Center”.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the to-be-constructed central Denver recreation center located at the northeast corner of Colfax Avenue and Josephine Street be and the same is hereby named, and shall be known as, CARLA MADISON RECREATION CENTER.

Section 2. That this action shall be effective upon the final adoption of the ordinance.
