**A BILL**

**For an ordinance making supplemental appropriations to Special Revenue Funds.**

**WHEREAS**, the Office of Economic Development is requesting additional appropriation in 2018 in the Affordable Housing Property Tax and Other Local Revenue Fund to re-establish budget that lapsed; and

**WHEREAS**, revenue to Denver Arts and Venues has increased by \$6,500,000 and DAV requests additional expending authority to accommodate the costs of more events in 2018; and

**WHEREAS**, Denver Human Services requests additional expending authority for the Child Care Fund to accommodate an increase in the City’s match requirement for child care subsidies, which is driven by a higher State FY2018-2019 allocation for the Colorado Child Care Assistance Program;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Office of Economic Development Special Revenue Fund, Accounting No. 16000 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1237, Series of 2017, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:


