A BILL

For an ordinance amending Ordinance No. 83, Series of 2019, to change the name of the “Parks, Trails, and Open Space” Special Revenue Fund to the “Parks Legacy” Special Revenue Fund, and amending Ordinance No. 687, Series of 2019, to change the names of the “Parks Debt Payments,” “Parks Citywide Projects,” and “Parks Improvement Projects,” Capital Project Funds to the “Parks Legacy Debt Payments,” “Parks Legacy Citywide Projects,” and “Parks Legacy Improvement Projects” Capital Project Funds, respectively.

WHEREAS, Ordinance Number 83, Series of 2019, established the Parks, Trails and Open Space Special Revenue fund, Fund number 15828, to administer the program approved by Denver voters in the 2018 election and supported by a 0.25 percentage point increase to the sales tax rate; and

WHEREAS, Ordinance Number 687, Series of 2019, established the “Parks Debt Payments,” “Parks Citywide Projects,” and “Parks Improvement Projects” Capital Project Funds to support the Program’s capital needs; and

WHEREAS, since the passage of said ordinances, the Department of Parks and Recreation has informally begun calling the program “Parks Legacy”; and

WHEREAS, the City wishes to change the name of the above Funds to reflect “Parks Legacy” in the Funds’ titles to align the official names with how the program is commonly referred;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Ordinance No. 83, Series of 2019, is hereby amended to reflect that the “Parks, Trails, and Open Space” Fund is now named the “Parks Legacy” Fund.

Section 2. Ordinance No. 687, Series of 2019, is hereby amended to reflect that the “Parks Debt Payments,” “Parks Citywide Projects,” and “Parks Improvement Projects” Capital Project Funds are now named the “Parks Legacy Debt Payments,” “Parks Legacy Citywide Projects,” and “Parks Legacy Improvement Projects,” respectively.

1 **Section 3.** The Chief Financial Officer of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be necessary
3 to accomplish the purposes of this Ordinance.
