A BILL

For an ordinance authorizing the transfer of cash from the City Council Special Revenue Fund to the Capital Improvements and Capital Maintenance Fund and making appropriations.

WHEREAS, Council District Four wishes to transfer unspent cash from its Special Revenue Fund to a capital project fund to support the Bible Park Playground;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. There is hereby authorized the transfer of cash from the General Government Special Revenue Fund to the Capital Improvements and capital maintenance fund:

From the Capital Improvements and Capital Maintenance Fund, Accounting No. 31000, out of moneys transferred in Section 1, and not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1216, Series of 2020, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
