**CR13-0661 A resolution approving the Mayor's appointments to the Denver Latino Commission.**

Approves the Mayoral appointments of Victoria Lovato, Joseph Montoya, Tariana Navas-Nieves, Benilda Samuels, and Jose Silva to the Denver Latino Commission effective immediately and expiring January 1, 2015, or until a successor is duly appointed. The Committee approved filing this resolution by consent on 10-3-13.

**CR13-0694 A resolution granting a revocable permit to SE Fillmore Place, LLC to encroach into the right-of-way at 2960 East 2nd Avenue.**

Grants a revocable permit to SE Fillmore Place, LLC to encroach into the public right-of-way with an Xcel transformer and a service connection cabinet on a concrete pad at 2960 E. 2nd Ave. on Milwaukee approximately 150 feet south of E. 2nd Ave. in Council District 10. The Committee approved filing this resolution by consent on 10-10-13.

**CR13-0695 A resolution granting a revocable permit to 212 South Broadway, LLC to encroach into the right-of-way at 218 South Broadway.**

Grants a revocable permit to 212 South Broadway, LLC to encroach into the public right-of-way with tables, chairs, gate, light fixtures, an airlock, and two sculptures at 218 S. Broadway in Council District 7. The Committee approved filing this resolution by consent on 10-10-13.

**CR13-0696 A resolution amending Resolution No. 59, Series of 2013, to include additional encroachments contained in the revocable permit issued to 1550 East 17th Avenue, LLC at 17th Avenue and Franklin Street.**

Amends Resolution No. 59, Series of 2013, granting a revocable permit to 1550 W. 17th Ave. LLC to include the following encroachments into the public right-of-way: steel roof with 5 columns, heating lamps, and ceiling fans at 1550 E. 17th Ave. in Council District 8. **CB13-0666 A bill for an ordinance approving a proposed Purchase Order between the City and County of Denver and Communications Supply Corporation related to electrical parts specific to Denver International Airport inventory.**

Approves a three-year and four-month, \$230,000 master purchase order with Communications Supply Corporation for electrical parts specific to Denver International Airport inventory (0742A0112). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-03-13.

**CB13-0678 A bill for an ordinance approving 16 proposed PVCP Amendments to Agreement between the City and County of Denver and certain concession related to operations and leased space at Denver International Airport.**

Amends sixteen (16) concession contracts to incorporate the Premium Value Concession Program language to allow the concessionaires to participate in the program and to compete for a new agreement upon expiration of their contract term. The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0698 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and URS Corporation for transportation planning and engineering services related to the Peña Boulevard Corridor at Denver International Airport.**

Approves a 3-year, \$1,584,938 contract with URS Corporation for professional transportation planning and a finance study for the development of capacity enhancements for the Peña Blvd. Transportation Corridor (201309450). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill at its meeting on 10-16-13.

**Government & Finance**

**CB13-0677 A bill for an ordinance amending D.R.M.C. Section 54-238, Child restraint systems, in order to reflect current state law.**

Amends the Denver Revised Municipal Code, Section 54-238, regarding child restraint systems to reflect current state law requiring restraints up to the age of eight (8). The Committee approved filing this bill by consent on 10-10-13.

**CB13-0679 A bill for an ordinance amending the City Retail Sales Tax Article, Article II, Chapter 53 of the Revised Municipal Code and the City Use Tax Article, Article III, Chapter 53 of the Revised Municipal Code to exempt purchases of aircraft parts, aircraft simulator parts, and rail carrier parts from taxation.**

Changes the sales and use tax of 3.62% in the City and County of Denver by phasing out its applicability to transportation utilities (airlines and rail) with a full exemption for these products by 2015. The Committee approved filing this bill at its meeting on 10-9-13.

**CB13-0704 A bill for an ordinance approving a proposed Purchase and Sale Agreement between the City and County of Denver and East 38th Avenue Properties, LLC, for the acquisition and disposition of certain land and buildings located at 3821-3851 Steele Street (otherwise known as 38th and York).**

Approves the purchase and sale of an industrial/warehouse property located at 3821-3851 Steele Street (otherwise known as 38th and York). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The

Committee approved filing this bill by consent on 10-10-13.

## **Health, Safety, Education & Services**

**CB13-0686 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States Department of Health and Human Services concerning the "Head Start FY13-14" program and the funding therefor.**

Amends the United States Department of Health and Human Services grant agreement to accept the Federal Head Start grant in the amount of \$4,182,673 to operate the Denver Great Kids Head Start program through the Office of Children's Affairs (201313087). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-3-13.

**CB13-0638 A bill for an ordinance relinquishing the easement granted to the City on June 1, 1974 in the Deed of Easement recorded with the Denver Clerk and Recorder in Book 893 at Page 79 generally located at Bryant Street and Front View Crescent.**

Relinquishes the easements established in Ordinance number 394, Series of 1957 at Bryant St. and Front View Crescent for redevelopment in Council District 1. The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 9-19-13.

**CB13-0663 A bill for an ordinance changing the zoning classification for 850 North Kalamath Street.**

Changes the zoning classification of 850 Kalamath from PUD (Planned Unit Development) #582 to G-MU-3 (General Urban Context, Multi-Unit, 3 stories) in Council District 9. A PUBLIC HEARING WILL BE HELD AT LEAST FOUR WEEKS AFTER PUBLICATION. The Committee approved filing this bill at its meeting on 10-8-13.

**CB13-0672 A bill for an ordinance approving an Amendatory Agreement between the City and County of Denver and OZ Architecture of Denver, Inc.**

Amends the on-call contract with OZ Architects to extend the term two years and add \$480,000, for a new total of \$960,000, as provided for in initial agreement, for professional architectural, engineering, and related technical services (201205580). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-3-13.

**CB13-0681 A bill for an ordinance approving a Temporary Construction License Agreement For Crane Rights, Construction Staging, Hammerhead and Trail Construction Activities from the City and County of Denver to Centennial Ventures IV, LLC at 1644 Platte Street.**

Approves of a Temporary Construction License Agreement regarding construction materials staging, crane rights, and street closures for Nichols Development in relation to construction at 1644 Platte St. in Council District 9. The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0682 A bill for an ordinance approving a Parking Agreement For Art Hotel And Broadway Office Building, a Temporary Construction License Agreement For Construction Staging And Temporary Closures and an Air Rights, Mechanical Equipment, Foundations And Columns, And Pedestrian Access Permanent Easement, all relating to the Denver Cultural Center Parking Garage and the adjacent hotel/office project at 1201 Broadway.**

Grants a permanent easement, a parking agreement, and a temporary license agreement related to the ART Hotel at 1201 Broadway in Council District 10. The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0689 A bill for an ordinance approving a proposed Agreement between the City and County of Denver and Colorado Designsapes, Inc., for construction of the new park between Newton and Osceola streets along Alameda.**

Approves a \$1,077,000 contract with Colorado Designsapes, Inc. for construction of the new park between Newton and Osceola streets along Alameda in Council District 3 (201312203). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0690 A bill for an ordinance approving a proposed Amendment to Agreement between the City and County of Denver and Urban Drainage and Flood Control District, to add additional funds.**

Adds \$250,000 of Wastewater enterprise funds and \$250,000 of Urban Drainage and Flood Control District funds, for a new total of \$1,200,000, to the agreement for improvements along Cherry Creek from Monaco to Iliff in Council District 6 (201103770-02). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0691 A bill for an ordinance approving a proposed Fifth Amendatory Agreement by and between the City and County of Denver and Xerox State & Local Solutions, Inc. f/k/a ACS State & Local Solutions, Inc., to extend the term of the agreement.**

Approves a no-cost extension for 6 months, through December 2014, of the contract with Xerox State & Local Solutions, Inc. for provision of Parking Management information systems and citation issuance, allowing for the completion of the competitive selection process and transition to a new contract/vendor (CE75006-5). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0692 A bill for an ordinance approving an Agreement between the City and County of Denver and Stantec Consulting Services, Inc.**

Approves a 2-year, \$720,315 contract with Stantec Consulting Services for traffic analysis and retiming of 225 traffic signals (201312883). The last regularly scheduled Council meeting within the 30-day review period is on 11-12-13. The Committee approved filing this bill by consent on 10-10-13.

**CB13-0693 A bill for an ordinance relinquishing the easement reserved in Ordinance No. 56, Series of 1936.**

Relinquishes certain easements established in Ordinance Number 56 Series of 1936 near 711 Park Avenue West for redevelopment in Council District 8. **CB13-0561 A bill for an ordinance approving a proposed Eighth Amendment to Agreement between the City and County of Denver and Skyport Development Company, LLC concerning subleasing and management of concessions on the mezzanine level of Concourse B at**

**Denver International Airport.**

Amends the Skyport Development Company, LLC agreement regarding (i) recapture of previously leased premises, (ii) the nature and amount of Skyport's additional investment in the B Mezzanine commons area, (iii) how the City and Skyport will share the cost of the additional investment in the B Mezzanine commons area and the improvement incentives offered to new subtenants, and (iv) the changes to the rent payable by Skyport at Denver International Airport (AC-69004). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 8-22-13.

**CB13-0668 A bill for an ordinance approving a proposed Second Amendment to Agreement between the City and County of Denver and PetroPro Engineering, Inc. for the management of the oil and gas wells at Denver International Airport.**

Adds two years and \$2,988,060 to the on-call professional services agreement with PetroPro for the management and operation of 76 oil and gas wells at Denver International Airport (CE 66003-02). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 10-3-13.

**Government & Finance****CB13-0664 A bill for an ordinance approving a proposed Master Purchase Order between the City and County of Denver and Dell Marketing, L.P., for computer equipment, peripherals and related services.**

Approves a two-year, \$150,000 master purchase order with Dell Marketing, L.P. for computer equipment, peripherals and related services (0506A0113). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 10-3-13.

**CB13-0665 A bill for an ordinance approving a proposed amendment to a Master Purchase Order between the City and County of Denver and Graybar Electric Company to extend the term for telecommunication hardware.**

Approves a two-year, \$150,000 master purchase order with Graybar Electric Company for telecommunication hardware (5761U0110). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 10-3-13.

**CB13-0669 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.**

Adds the classification of Environmental Public Health Investigator III (810-E) to the City Classification and Pay Plan. The Committee approved filing this bill by consent on 10-3-13.



**CB13-0670 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service.**

Adds the classifications of Aviation Security Agent (613-C) and Senior Aviation Security Agent (614-C) to the City Classification and Pay Plan. The Committee approved filing this bill by consent on 10-3-13.

**Health, Safety, Education & Services**

**CB13-0667 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the State of Colorado concerning the "Colorado Prevention Partnership for Success" program and the funding therefor.**

Accepts and appropriates the Colorado Prevention Partnership for Success grant from the Colorado Department of Human Services' Division of Behavioral Health in the amount of \$400,000 for fiscal year 2013-2014 for a total funding of \$1,846,328 for substance abuse prevention strategies for youth (GC00018 (6)). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 10-3-13.

**Land Use, Transportation & Infrastructure**

**CB13-0654 A bill for an ordinance vacating an alley bounded by Blake Street, Walnut Street, 28th Street and 29th Street, with reservations.**

Vacates an alley bounded by Blake, Walnut, 28th and 29th streets to help reduce litter, graffiti, and dumping, after determining the alley is not needed for access, service or transportation in Council District 9. The Committee approved filing this bill by consent on 9-26-13.

**CB13-0656 A bill for an ordinance approving a Contract between the City and County of Denver and Mark Young Construction, Inc.**

Approves a \$1,424,013, 123-day contract with Mark Young Construction for replacement of spotlight booths and concession stands in Red Rocks Amphitheater. The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 9-26-13.

**CB13-0671 A bill for an ordinance approving an amendatory agreement between Wember, Inc. and the City & County of Denver for the West Denver Library Project.**

Amends the contract with Wember, Inc. to extend the term through June 2015 and adds \$280,372, for a new total of \$726,372, for Professional Project Management Services on the new Rudolfo Corky Gonzales Library construction in Council District 1 (201102693). The last regularly scheduled Council meeting within the 30-day review period is on 11-4-13. The Committee approved filing this bill by consent on 10-3-13.
