**A BILL**

**For an ordinance approving a proposed donation of surplus equipment from the City and County of Denver to the Open Media Foundation.**

**WHEREAS**, the Open Media Foundation (“OMF”) spent several years serving as the City and County of Denver’s public access provider, under a cable franchise agreement; and

**WHEREAS** the agreement between OMF and the City and County of Denver (“City”) ended December 19, 2018, and City has surplus equipment currently located in the operational office of OMF; and

**WHEREAS**, the City wishes to donate this surplus equipment to OMF and a list of the equipment is on file with the Denver Clerk and Recorder’s Office as Clerk File No. 20200081; and

**WHEREAS**, the City has moved to a community media model and has worked to strategically determine the most prudent allocation of resources to community partners to best serve residents; and

**WHEREAS**, the City intends to donate such equipment to support OMF’s non-profit services that work to improve media literacy and to strengthen community engagement; and

**WHEREAS**, the proposed donation of surplus equipment cannot be made until after approval by City Council and the Mayor in accordance with §2.9.3(C); and

**WHEREAS**, §2.9.3(C) of the Charter of the City and County of Denver authorizes the donation of surplus supplies, equipment, and personal property to charitable or nonprofit organizations, School District No. 1, or other governmental jurisdictions; and

**WHEREAS**, OMF is a Colorado non-profit corporation that provides multimedia services and education to non-profit and public-sector organizations; and

**WHEREAS**, the Manager of General Services has declared as surplus all City owned equipment currently located at OMF; and

**WHEREAS**, the value of the equipment proposed to be donated is \$159,194.65 as of May 13, 2020.

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed donation of equipment owned by the City, as described in Clerk

1 File No. 20200081 with the Denver Clerk and Recorder's Office, and currently in use by OMF for  
2 content production allows OMF to continue to support not-for-profit public content production, is  
3 hereby approved.
