This is a Grant IGA with Cherry Hills Village, Arapahoe County and Denver for a cost sharing of the Match required by the Colorado Department of Transportation (CDOT) Highline Canal IGA 201628095-to provide funding for new 10 foot multi-use trail and two trail underpasses, with one under Colorado Boulevard and the other under Hampden Avenue.

also accommodate bicycles and pedestrians by providing covered bicycle parking spaces, ADA/AASTO compliant lighting, and way finding signage with destination and distance information.

f. Contract Amount (indicate amended amount and new contract total):

This IGA is a cost sharing agreement with each party providing \$450,000 for a total of \$1,350,000.00, which is the match to be used in the CDOT Highline Canal IGA.

The Highline Canal IGA allows for the transfer of \$4,050,000.00 in Federal funding to the City and County of Denver for design and construction of the referenced project.
