4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**  
6 **of land as South Colorado Boulevard, located at the intersection of South**  
7 **Colorado Boulevard and East Ellsworth Avenue.**

8 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of  
9 the City and County of Denver has found and determined that the public use, convenience and  
10 necessity require the laying out, opening and establishing as a public street designated as part of  
11 the system of thoroughfares of the municipality that portion of real property hereinafter more  
12 particularly described, and, subject to approval by resolution has laid out, opened and established  
13 the same as a public street;

14 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

15 **Section 1.** That the action of the Executive Director of the Department of Transportation  
16 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of  
17 the municipality the following described portion of real property situate, lying and being in the City  
18 and County of Denver, State of Colorado, to wit:

21 A PARCEL OF LAND CONVEYED BY SPECIAL WARRANTY DEED TO THE CITY AND

23 NUMBER 2021077259 IN THE CITY AND COUNTY OF DENVER CLERK AND RECORDER'S  
24 OFFICE, STATE OF COLORADO, THEREIN AS:

26 THE WEST 2.00 FEET OF PLOT 1, BLOCK 53, EASTERN CAPITOL HILL SUBDIVISION.  
27 SITUATED IN THE SOUTHWEST QUARTER OF SECTION 7, T4S, R67W OF THE 6TH P.M.,  
28 CITY AND COUNTY OF DENVER, STATE OF COLORADO.

30 CONTAINING 200 SQUARE FEET (0.005 ACRES), MORE OR LESS
