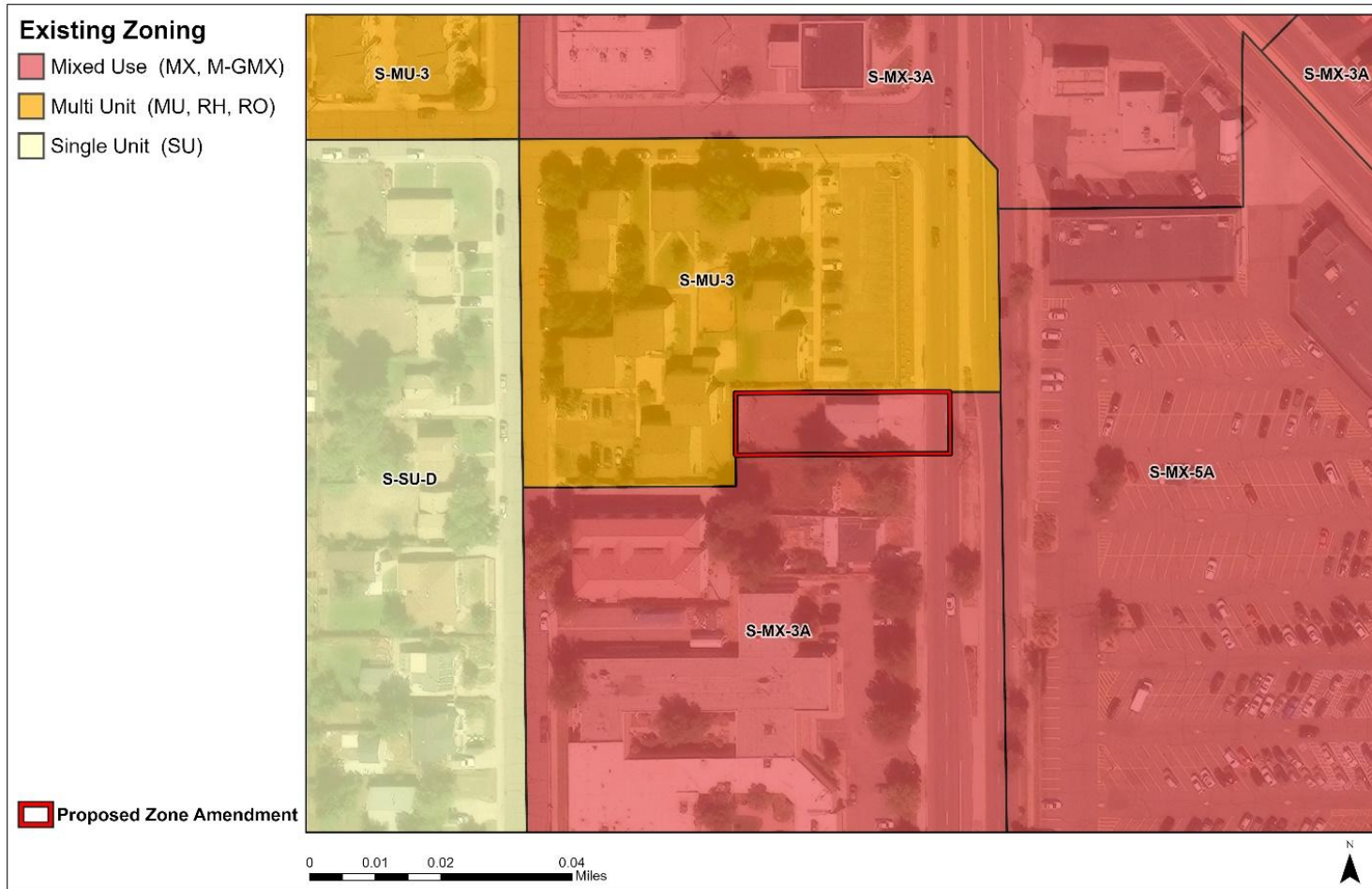
Request: S-MX-3A to S-MU-3



- Property:
 - 7,050 S.F. (0.16 acres)
 - Single-unit housing

Reminder: Approval of a rezoning is not approval of a proposed specific development project

Existing Zoning – S-MX-3A



Combine the parcel with 801 S. Monaco (S-MU-3)

Affordable Housing

- Combine the parcel with 801 S. Monaco (S-MU-3)
- 801 S. Monaco is deed-restricted with 28 units- a mix of 2, 3, & 4 bedrooms
- Goal of 75 units - AMI mix of 30-60%
- Applying Low Income Housing Tax Credits (LIHTC)

Current Zoning – S-MX-3A

Suburban – Mixed Use – 3 Stories, A

Intent:

Design standards encourage a more pedestrian oriented environment.

Building Forms:

- General building form
- Shopfront

Proposed Zoning – S-MU-3

Suburban – Multi-unit – 3 stories

Specific Intent:

- A multi unit district allowing apartments 3 stories in height

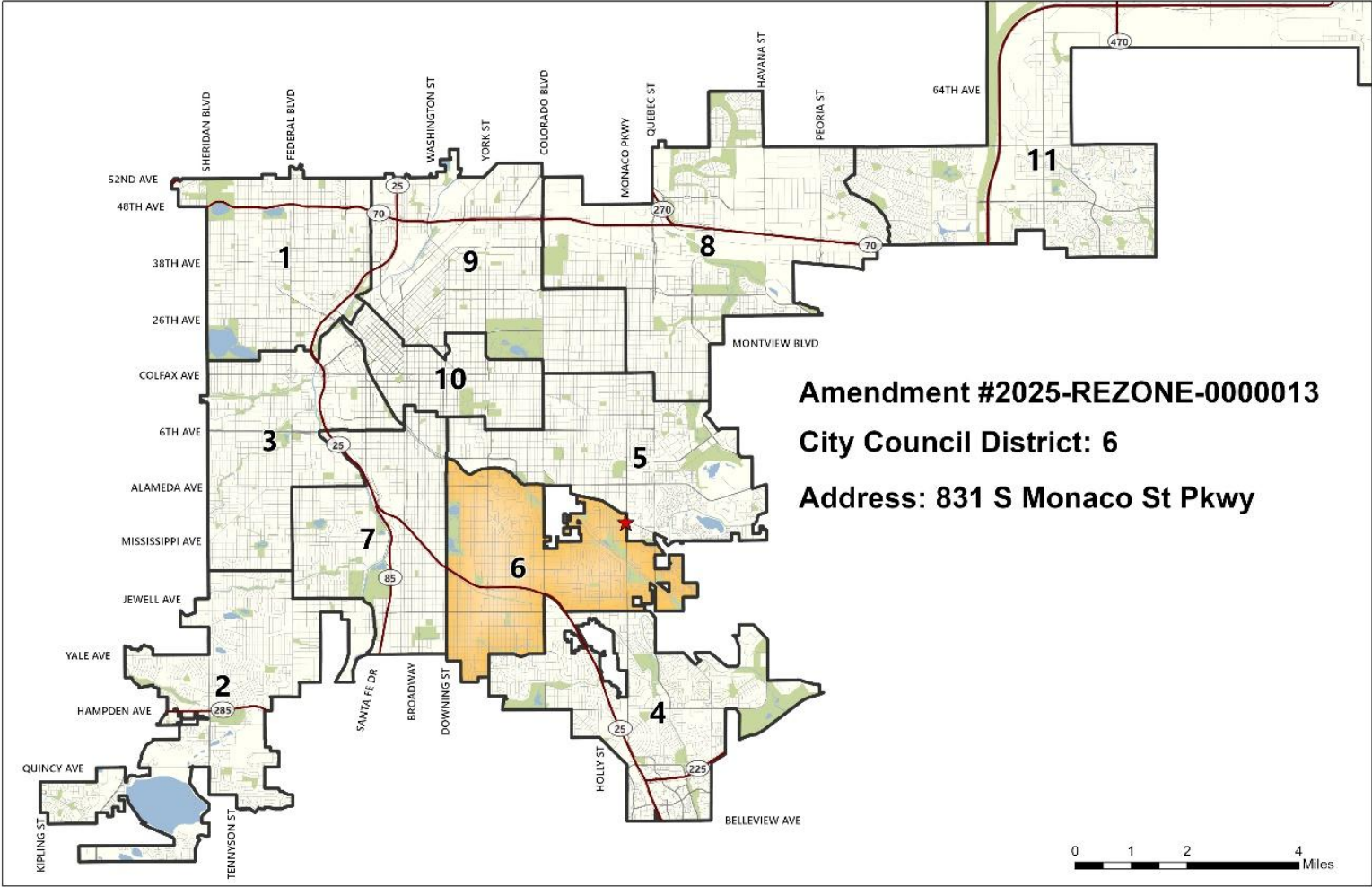

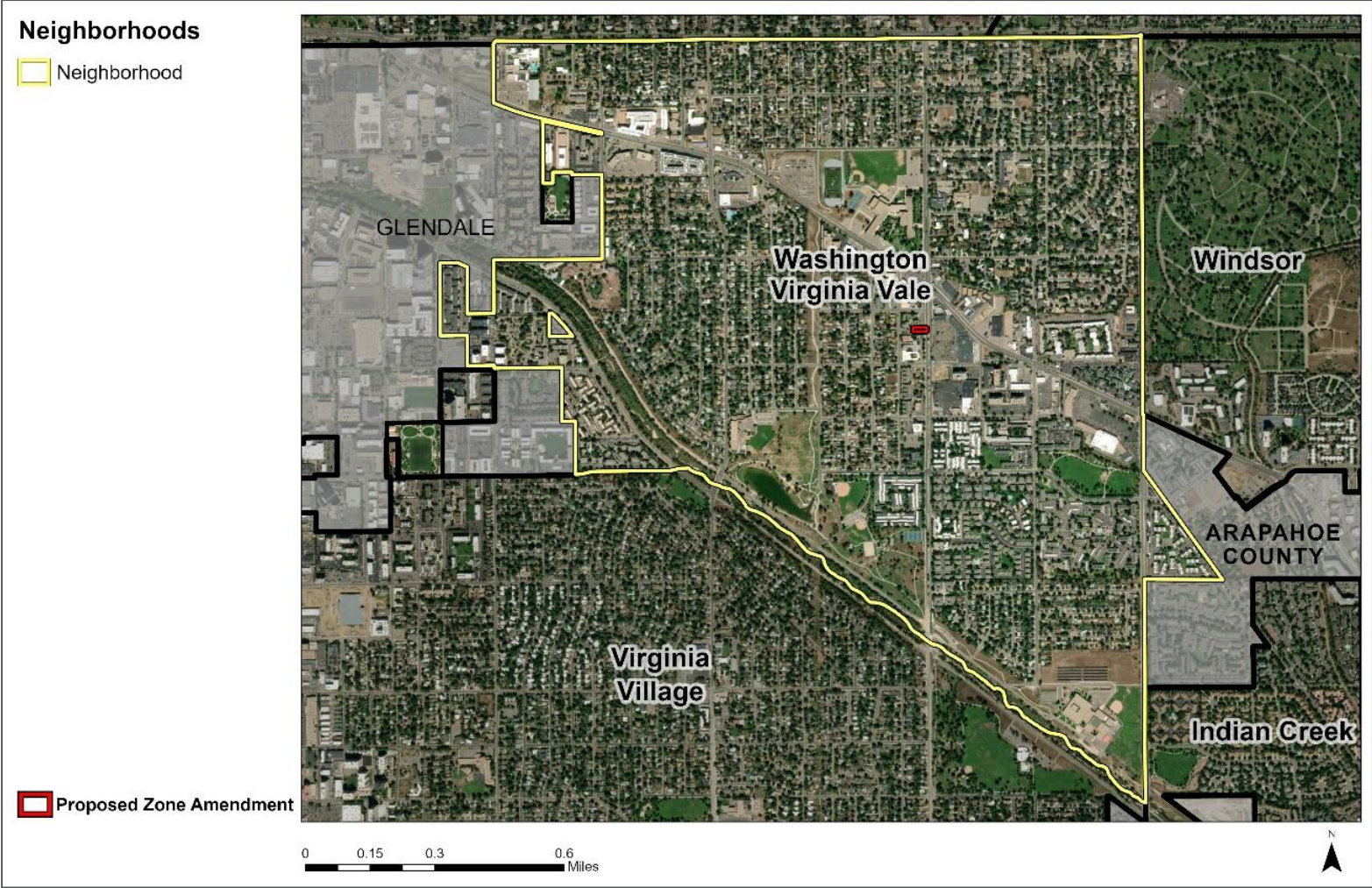

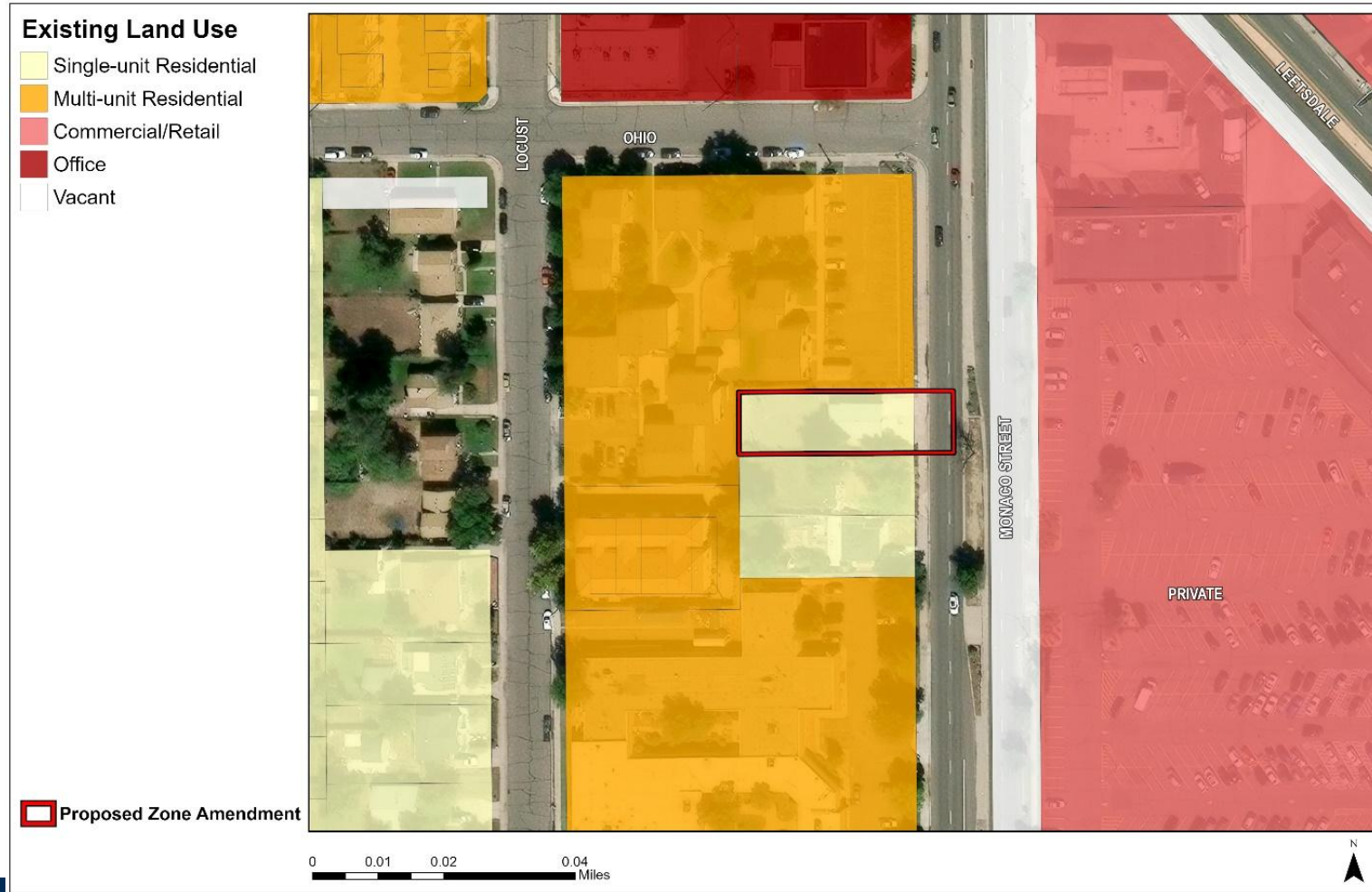
Council District 6 – Councilmember Kashmann

Existing Context – Land Use

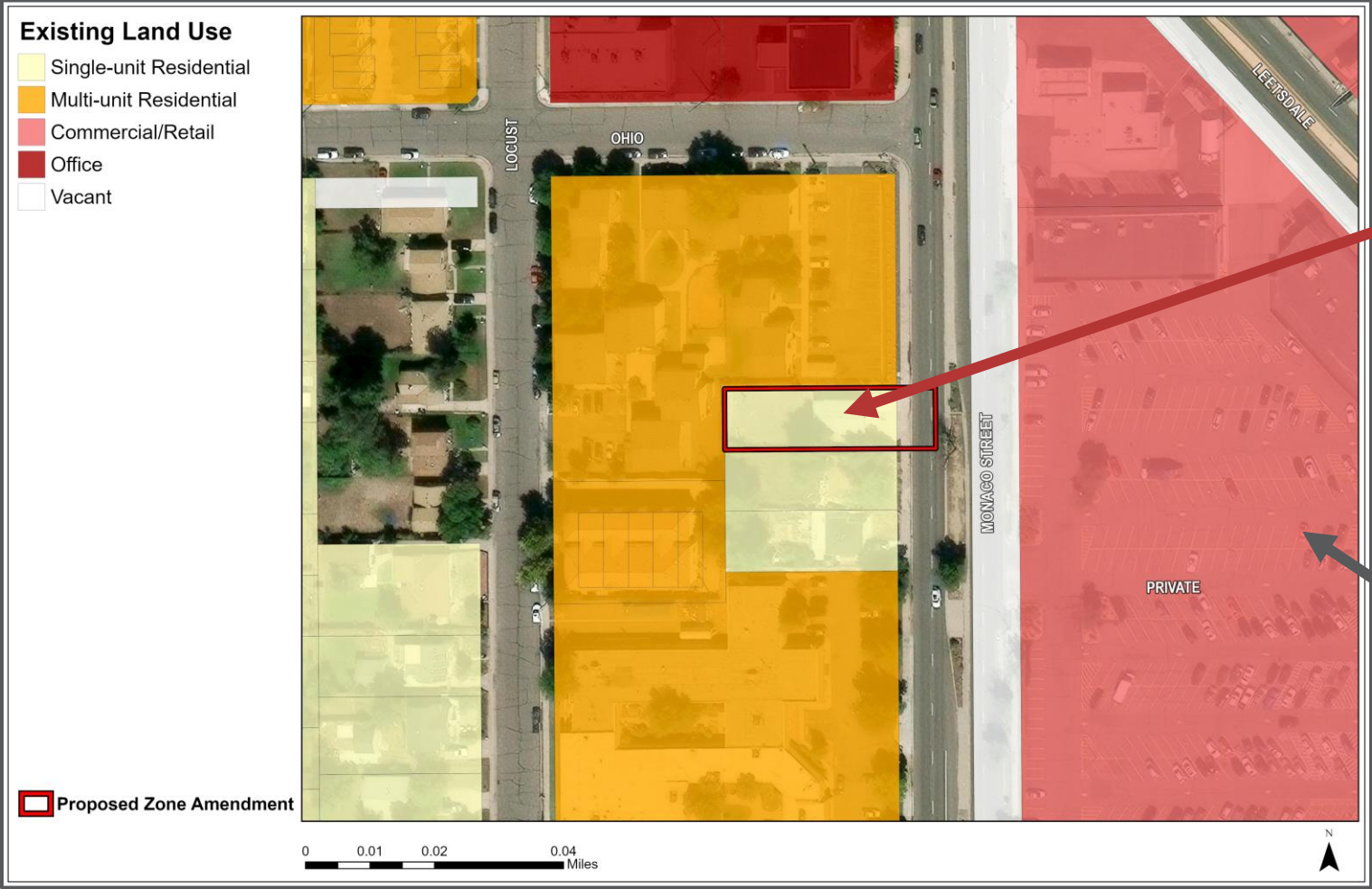

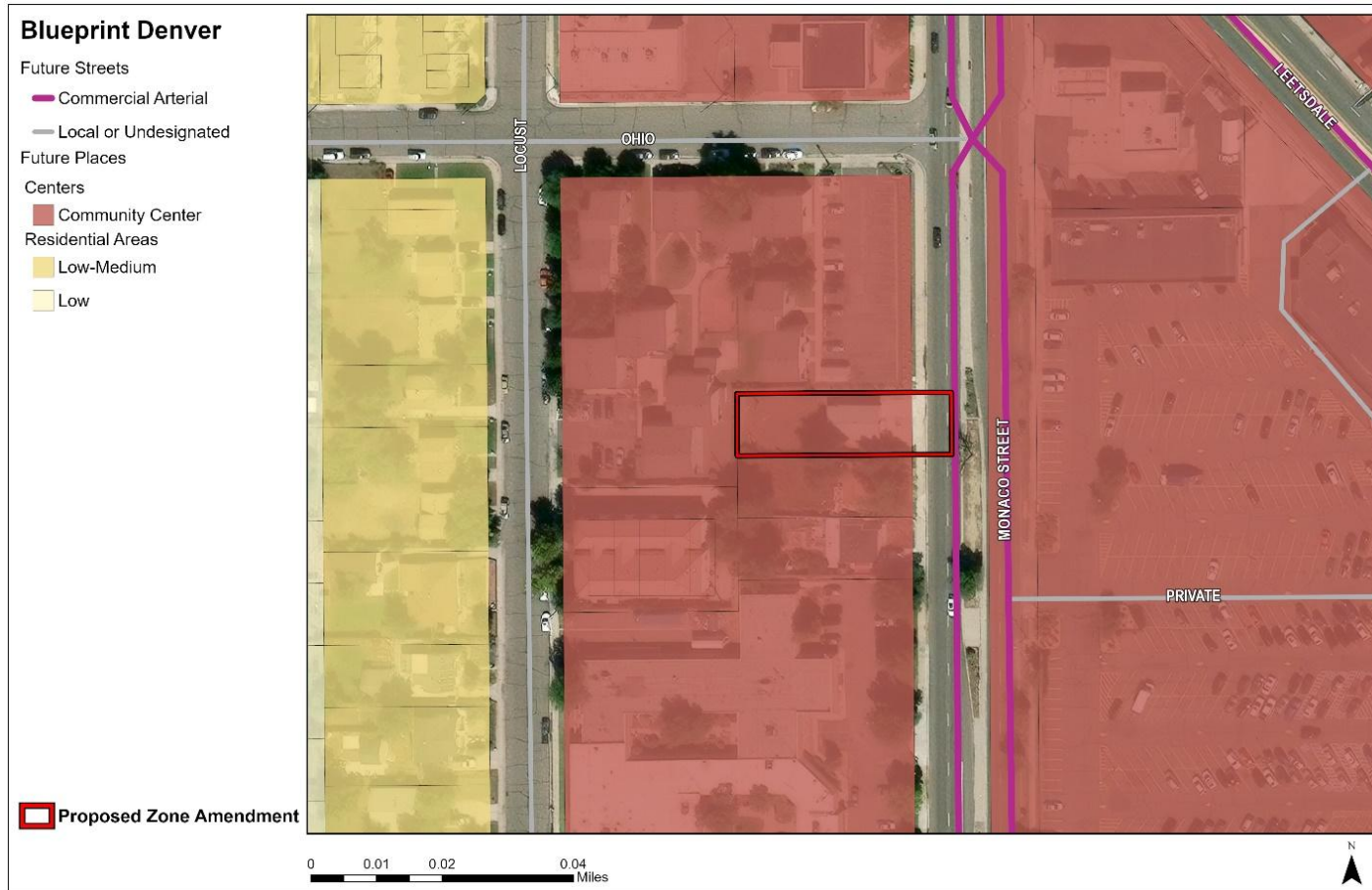
Blueprint Denver 2019



Suburban – Neighborhood Context

- Largely single-unit
- Include higher intensity residential

Blueprint Denver 2019



Place Type: Community Center

- Mix of office, commercial and residential uses
- Up to 5 stories in height

Street Type:

- Monaco Street Parkway – Commercial Arterial

Evaluation is based on the proposed zone district is consistent with the Future Street Classification, not to assess the traffic impacts of a specific development proposal.

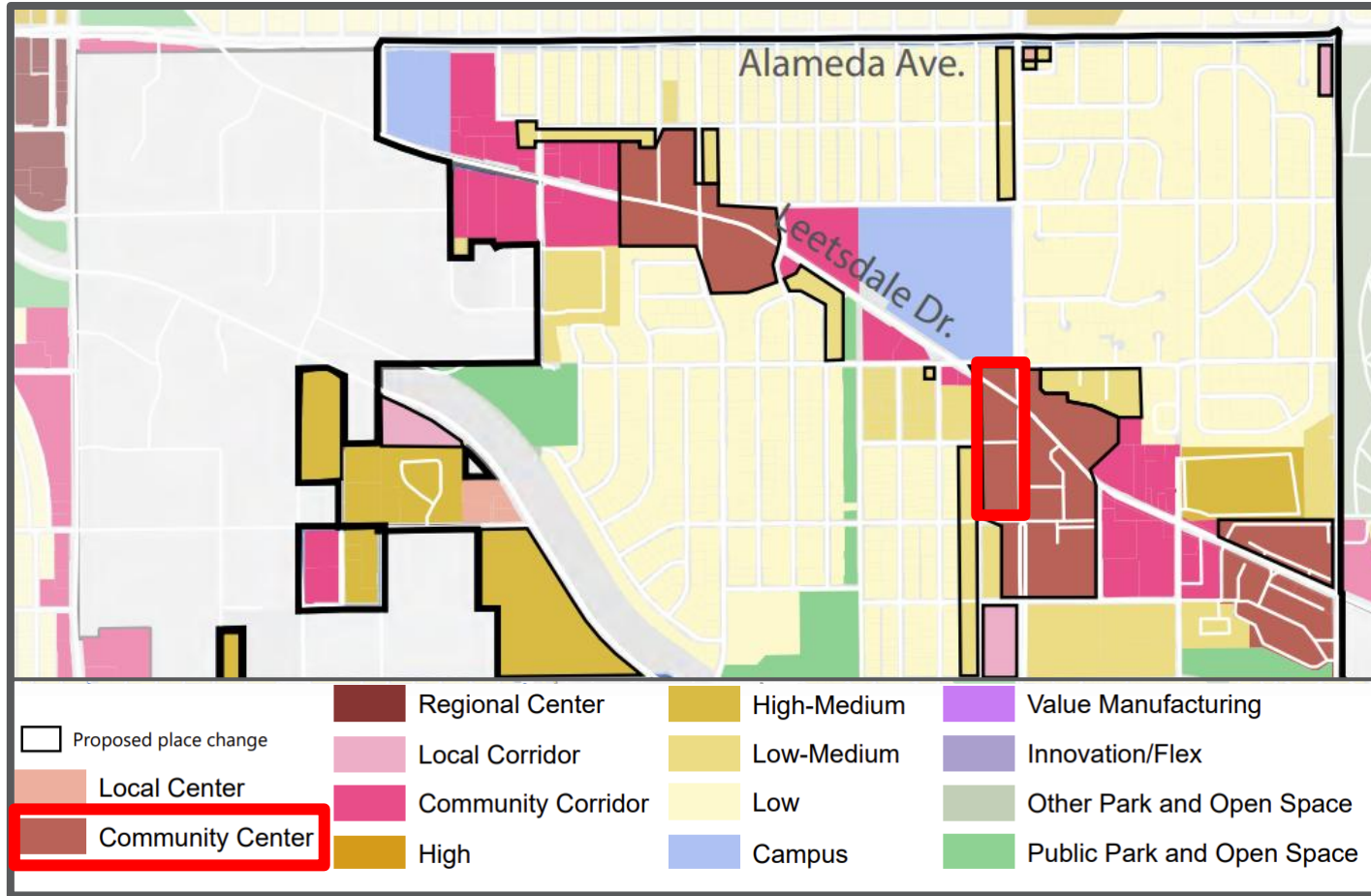

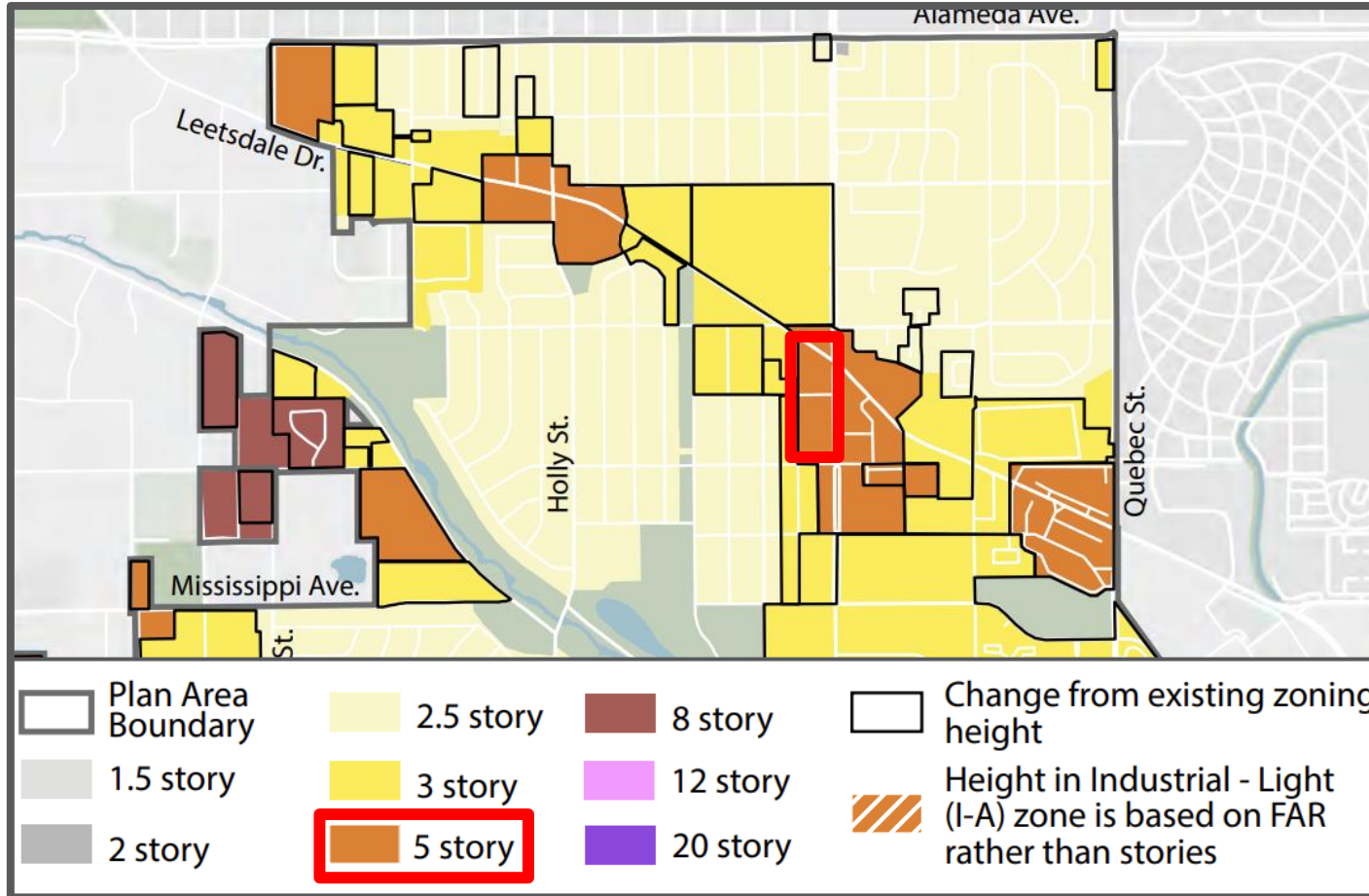
