Purpose:

The Denver African American Commission (DAAC) is tasked with advising the Agency for Human Rights & Community Partnerships Executive Director and the Mayor on issues and concerns that impact and are of importance to the African American community. DAAC serves as a bridge between the African American community and policymakers and engage in responsible activism for the community.

Appointment Process:

The Mayor appoints up to 21 members and City Council confirms appointments for a term of 3 years up to 3 terms.
