- Denver Police Department provision of School Resource Officers at various Denver Public School locations throughout the 2014-2015 school year
- Anticipated revenue for said period is projected at \$643,714.00; a nominal increase from 2013-2014. This contract is an amendment that adds a third year to the current agreement, bringing the three-year revenue total to \$1,922,074.00
