10 **Spencer and John R. Fuller, P.C., Forty-Five Thousand Dollars (\$45,000) made**  
11 **payable to Judy Webster and John R. Fuller, P.C., and Twenty-Five thousand**  
12 **dollars (\$25,000) made payable to Alyson McCumsey and John R. Fuller, P.C,**  
13 **in full payment and satisfaction of any and all claims related to the civil action**  
14 **captioned *Misty Spencer, Alyson McCumsey, and Judy Webster v. James***  
15 ***Waidler and the City and County of Denver*, which was filed in the Denver**  
16 **District Court, Case No. 2021CV32776.**

18 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

20 **Section 1.** That the Council of the City and County of Denver hereby approves and authorizes  
21 the expenditure and payment from the 2022 appropriation account designated as “Liability Claims”  
22 (Accounting Number 11827 4511001), the sum of One Hundred Eighty-Five Thousand Dollars  
23 (\$185,000.00) distributed as follows: One Hundred and Fifteen Thousand dollars (\$115,000.00)  
24 made payable to Misty Spencer and John R. Fuller, P.C., Forty-Five Thousand Dollars (\$45,000)  
25 made payable to Judy Webster and John R. Fuller, P.C., and Twenty-Five thousand dollars  
26 (\$25,000) made payable to Alyson McCumsey and John R. Fuller, P.C, in full payment and  
27 satisfaction of any and all claims related to the civil action captioned *Misty Spencer, Alyson*  
28 *McCumsey, and Judy Webster v. James Waidler and the City and County of Denver*, which was filed  
29 in the Denver District Court, Case No. 2021CV32776. Payment is to be made upon the execution  
30 and delivery of such release or releases as is or are satisfactory to the attorney for the City and  
31 County of Denver.

32 **Section 2. The Manager of Finance is hereby authorized and directed to make such book**  
33 **and record such entries and to do such other things as may be necessary to accomplish**  
34 **the purposes of this resolution.**
