15 **WHEREAS**, the State of Colorado has tendered to the City a Grant award for said program;

18 amended Grant Agreement;

20 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**

23 **Section 1.** The proposed amended Grant Agreement, under CFDA No. 93.569, between the
24 State of Colorado and the City and County of Denver, which is identified as Grant Number
25 L15CSBG13, a copy of which is duly filed with the City Clerk, Filing No. 15-0204-002, be and
26 hereby is approved in all respects.

28 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
29 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund
30 No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the
31 City and County of Denver.
