17	previously agreed to a modification of the I	Franchise related to the allocation of Public
18	Access channels; and	
19	WHEREAS, pursuant to Ordinance N	No. 532, Series 2008, the City and Comcast
20	agreed to extend the term of the original Fra	nchise for an additional three years; and
21	WHEREAS, according to Section 2.3	(A) of the Franchise, as amended, the term
22	of the Franchise is currently scheduled to er	nd on December 31, 2012; and
23	WHEREAS, the City and Comcast a	re currently engaged in negotiations for the
24	renewal of the franchise; and	

WHEREAS, representatives of the City and Comcast have met and conferred,
and agreed that the term of the existing Franchise should be extended for an additional
six months while maintaining all other terms and conditions of the Franchise intact
during the period of the extension, in order to provide additional time for negotiation of
the renewal of the Franchise; and
WHEREAS, Section 4.9 of the Franchise authorizes the Franchise to be modified
upon mutual agreement of the parties;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The Franchise heretofore granted by the City to Comcast is hereby amended as follows:

Amendment to Cable Franchise Agreement

Section 2.3 (A) of the Franchise is hereby modified to read as follows:

2.3.1 Effective Date and Term of Franchise

(A) The Franchise and the rights, privileges and authority granted hereunder shall take into effect on January 1, 2000 (the "Effective Date") and shall terminate on June 30, 2013, unless terminated sooner as hereinafter provided.

Except as specifically set forth herein, all other terms and conditions of the
Franchise shall remain in full force and effect during the extended term of the Franchise
including by way of example but not by way of limitation the amendatory terms
previously set forth in Ordinance No. 218, Series 2007 concerning allocation of Public
Access channels.

Neither Comcast nor the City waives any right which it enjoys under law as a result of agreeing to this Franchise extension, and Comcast shall not be required to file any additional request or document in order to preserve its right of renewal under Section 626 of the Cable Act.
