6 **For an ordinance relinquishing the easements, in its entirety, established in the**
7 **Easement Agreement, Permanent Easement for Public Access, Permanent**
8 **Easement for Right-of-Way Area and Permanent Non-Exclusive Easement,**
9 **recorded with the Denver Clerk & Recorder at Reception No. 2021090422 located**
10 **at 2720 South Federal Boulevard.**

11 **WHEREAS**, the Executive Director of the Department of Transportation and Infrastructure of
12 the City and County of Denver has found and determined that the public use, convenience and
13 necessity no longer require the easements in the above-referenced Easement Agreement,
14 Permanent Easement for Public Access, Permanent Easement for Right-of-Way Area and
15 Permanent Non-Exclusive Easement, and subject to approval by ordinance, has relinquished the
16 same;

17 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

18 **Section 1.** That the action of the Executive Director of the Department of Transportation
19 and Infrastructure in relinquishing the easements established in the Easement Agreement,
20 Permanent Easement for Public Access, Permanent Easement for Right-of-Way Area and
21 Permanent Non-Exclusive Easement, recorded with the Denver Clerk & Recorder at Reception No.
22 2021090422, be and the same is hereby approved and that the easements in the above-referenced
23 Easement Agreement, Permanent Easement for Public Access, Permanent Easement for Right-of-
24 Way Area and Permanent Non-Exclusive Easement are hereby relinquished.
