**A BILL**

**For an ordinance approving an Intergovernmental Agreement between the City and County of Denver and the Denver Board of Water Commissioners for the City's Broadway Reconstruction Project.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Intergovernmental Agreement between the City and County of Denver and the Denver Board of Water Commissioners, in the words and figures contained and set forth in that form of Intergovernmental Agreement, available in the office and on the web page of City Council, and filed in the office of the City Clerk on June 30, 2014, under City Clerk's Filing No. 2014-0583, is hereby approved.

**Section 2.** A new Fund is hereby established in the Grant/Other Capital Projects Fund, Accounting No. 38000, for the project indicated in the following tabulation:
