

## THIRD AMENDATORY AGREEMENT

**THIS THIRD AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado ("City"), and **Flatiron Dragados Constructors, Inc.**, a Delaware corporation registered to do business in Colorado, whose address is 385 Interlocken Crescent Suite 900, Broomfield, CO 80021, formerly known as **FLATIRON CONSTRUCTORS, INC.** Flatiron Dragados Constructors, Inc. is referred to herein as Consultant.

### RECITALS:

**WHEREAS**, FLATIRON CONSTRUCTORS, INC. entered into a Services Agreement dated September 16, 2020 an Amendatory Agreement dated March 15, 2023 and a Second Amendatory Agreement dated April 17, 2024 (the "Agreement"), to provide preconstruction services; and

**WHEREAS**, in January 2025 Flatiron Constructors, Inc., changed its name to Flatiron Dragados Constructors, Inc.

**WHEREAS**, the City and the Consultants mutually desire to amend the Agreement to reflect the name change.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the parties hereto mutually agree as follows:

1. All references to "Flatiron Constructors, Inc.", shall be amended to read "Flatiron Dragados Constructors, Inc.".
2. As herein amended, the Agreement is affirmed and ratified in each and every particular.
3. This Third Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
