## A RESOLUTION

Accepting and approving the plat of Stapleton Filing No. 35.
WHEREAS, the property owner of the following described land, territory or real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

18.) North $00^{\circ} 00^{\prime} 00^{\prime \prime}$ West a distance of 61.16 feet to a point of non-tangent curve;
19.) along the arc of a curve to the left having a radius of 330.00 feet, a central angle of $2^{\circ} 27^{\prime} 38^{\prime \prime}$, an arc length of 14.17 feet and whose chord bears North $81^{\circ} 06^{\prime} 50$ " West a distance of 14.17 feet;
20.) North $00^{\circ} 00^{\prime} 00^{\prime \prime}$ West a distance of 88.93 feet to a point of curve;
21.) along the arc of a curve to the right having a radius of 50.00 feet, a central angle of $28^{\circ} 16^{\prime} 03^{\prime \prime}$, an arc length of 24.67 feet and whose chord bears North $14^{\circ} 08^{\prime} 01$ " East a distance of 24.42 feet;
22.) North $28^{\circ} 16^{\prime} 03^{\prime \prime}$ East a distance of 141.27 feet to a point of non-tangent curve;
thence along the arc of a curve to the left having a radius of 1246.00 feet, a central angle of $48^{\circ} 33^{\prime} 30^{\prime \prime}$, an arc length of 1055.99 feet and whose chord bears South $71^{\circ} 50^{\prime} 10^{\prime \prime}$ East a distance of 1024.67 feet; thence North $83^{\circ} 53^{\prime} 05^{\prime \prime}$ East a distance of 30.94 feet;
thence North $05^{\circ} 00^{\prime} 00^{\prime \prime}$ West a distance of 50.01 feet to the southerly line of Havana Way as described by Ordinance 127, Series of 1954 in said Clerk and Recorder's Office;
thence North $83^{\circ} 53^{\prime} 05^{\prime \prime}$ East, along said southerly line of Havana Way, a distance of 68.01 feet; thence South $05^{\circ} 00^{\prime} 00^{\prime \prime}$ East a distance of 50.01 feet;

Section 1. That the Council hereby finds and determines that said land, territory, or real property has been platted in strict conformity with the requirements of the Charter of the City and

County of Denver.
Section 2. That the said plat or map of Stapleton Filing No. 35 be and the same are hereby accepted by the Council of the City and County of Denver.
