## **CURRENT BOARD STATUS**

Staff Liaison: Greg Mauro, Division of Community Corrections | Department of Safety

**Scope of Board/Commission:** The Denver Community Corrections Board oversees the acceptance and rejection criteria for all offenders considered for placement in the Denver Community Corrections Residential program.

The Board is made up of representatives across the criminal justice spectrum.

• 10 represent criminal justice and human services departments, one represents Victim Services, Two have experience or expertise in criminal justice, Six are citizens of the City and County of Denver, One is a locally elected official, One is a representative of Denver Public Schools

**Appointment Process:** The Board has 21 members who are appointed by the Mayor and confirmed by City Council for 4 year terms.

Appointment Candidate Term: 11/01/2024 - 10/31/2028 or until a successor is duly appointed.



## **Rachel Rodriguez**

**Bio:** Rachel Rodriguez is a dedicated and passionate advocate for survivors of violence who strives to increase awareness on the issues of domestic violence and works toward ending it. She has devoted over 15 years to working with survivors at the local, state, and national levels. Rachel is currently the Associate Director at the Rose Andom Center and was previously the Director of the Domestic Violence Outreach Program at Family

Tree, Inc. She also worked as the Bilingual Advocate & Crisis Line Volunteer Supervisor at Safehouse Denver. Before coming to Colorado eight years ago, Rachel served as the Manager of Hotline Services for the National Domestic Violence Hotline. There, she managed staff, assisted in facilitating trainings as well as train-the-trainer trainings to advocates traveling throughout the country and as far as the Northern Mariana Islands.
