CYDC program staff are responsible for screening youth who have been charged with a misdemeanor and/or felony offense to determine release disposition and providing pre-trial release services which allows the youth to be supervised in the community in lieu of remaining in detention while the case proceeds through the juvenile justice system.

Who are the subcontractors to this contract?

DPSYP has eight subcontractors. Behavioral Interventions (BI) provide electronic home monitoring (EHM) services and was selected as the provider via a competitive RFP issued by the city. Savio House (SH) provide family/individual therapeutic interventions such as Multi-Systemic Therapy and Trauma-Focused Cognitive Behavioral Therapy. Seeing Our Adolescents Rise (SOAR) provides mentoring and academic support services; Success 4 Life provides tutoring services; Fully Liberated Youth (FLY) provides mentoring and therapeutic services; Resolute Youth Services (RYS) provide individual/family/group therapy, substance use and mental health evaluations and parent coaching. Cordant provides urinalysis testing services, and the Jefferson County Juvenile Assessment Center provides after hours and weekend detention screening services.
