**A BILL**

**For an ordinance amending Ordinance No. 591, Series of 2021, to allocate an initial amount of spending in the American Rescue Plan Act Grant Fund.**

**WHEREAS**, Ordinance No. 591, Series of 2021, established the American Rescue Plan Act (ARPA) Grant Fund, Fund No. 11011, and accepted the Coronavirus Local Fiscal Recovery Fund award agreement with the US Department of Treasury; and

**WHEREAS**, Ordinance No. 591 accepted the full \$308,048,870 identified in the award agreement, and included provisions requiring that City Council approve any spending in the fund through amendments to said Ordinance; and

**WHEREAS**, this Ordinance amends Ordinance No. 591, Series of 2021, by adding a section to authorize an initial amount of spending in the Fund, specific to the “Revenue Loss” category, identified as an allowable expense in the ARPA guidance; and

**WHEREAS**, this initial allocation is limited to 2021 Revenue Loss expenses and includes the cost of restoring furloughs for all City employees in 2021, the cost of restoring some services that were reduced in 2021 to balance the budget as a result of revenue loss from COVID-19, and the cost of addressing certain operational backlogs that arose as resources were reduced or diverted due to the pandemic; and

**WHEREAS**, after the 2022 budget is released, one or more future ordinances will be submitted to authorize spending in the ARPA Grant Fund for the 2022 portion of costs associated with these services;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Section 6 of Ordinance No. 591, Series of 2021, is hereby amended to be Section 7.

**Section 2.** Section 5 is amended to read as follows:

1       **“Section 5.** That it be and is hereby found and determined that the total budget summary of said  
2 program is as follows:

5 The foregoing budget summary reflects the total Coronavirus Local Fiscal Recovery Fund grant  
6 agreement. City Council shall authorize spending for ARPA-approved categories through  
7 amendments to Ordinance No. 591, Series of 2021. Expenditures of said funds are authorized from  
8 March 3, 2021 to December 31, 2026.”

10       **Section 3.** A new Section 6 is hereby added to Ordinance No. 591, Series of 2021, to be read  
11 as follows:

13       “That it be and is hereby found and determined that the initial 2021 allocation for the Revenue  
14 Loss spend category, as defined in ARPA guidance, is as follows:

17 The foregoing Revenue Loss allocation supports the cost of furlough restoration for all City  
18 employees, the cost of restoring some services that were reduced in 2021 to balance the budget  
19 as a result of revenue loss from COVID-19, and the cost of addressing certain operational  
20 backlogs that arose as resources were reduced or diverted due to the pandemic.”

22       **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
23 and directed to make such book and record entries and to do such other things as may be necessary  
24 to accomplish the purposes of this Ordinance.
