Charlie Brown joins Hoban Law Group as a government consultant and cannabis regulatory policy specialist. He brings a wealth of experience



brings a wealth of experience and knowledge concerning the oft-difficult issues faced by community members and stakeholders that accompany the

legalization of medical and/or recreational marijuana.

In late July 2015, Brown completed his term as the longestserving member of the Denver City Council, where he was known as the "Cowboy Councilman" for his moderate, business-oriented perspective. He also received national media attention for his work as chairman of the medical and recreational marijuana council committees. Prior to his election to the Denver City Council, Brown served two years as a Colorado State Representative.

Brown was the key sponsor of Denver's medical marijuana ordinance that was approved by Colorado voters in 2010. In 2013, after voters subsequently legalized recreational marijuana use in Colorado, Brown's leadership helped define and implement Denver's ordinances to regulate the marijuana industry, the first city to do so in the world, that are now considered a national standard.

In addition, Brown was the Denver Chair of the Amendment 64 legalization committee that was responsible for evaluating potential impacts of legalization on Denver's businesses and

View more in the HLG Media Center residents. He also chaired many marijuana-related study groups prior to recreational legalization.

In June 2015, Brown was asked to present to Costa Rican government officials at the first ever Latin American Medical Marijuana conference. He spoke from experience to a large audience on the nuances of government policy and regulation surrounding Denver's own legalization efforts.

Brown has a national media presence that includes appearances on "The O'Reilly Factor," "ABC's World News Sunday," NBC and CBS News and "The Daily Show with Jon Stewart." He has been quoted in the Wall Street Journal, The Los Angeles Times, The New York Times and Forbes.

Brown's diverse background includes serving as president of an award-winning public relations firm, as chief lobbyist for a statewide medical society, as a teacher at the secondary and collegiate levels and work as a Realtor. His favorite summer job was working as a river guide on the Snake River in Grand Teton National Park, Jackson, Wyoming.

A love of the West drew Brown to the University of Wyoming, where he earned a bachelor's degree in political science. In 2014 Brown was named a distinguished alumni for the University of Wyoming College of Arts and Sciences. Brown and his wife of 33 years, Suzanne, have two sons, ages 27 and 23. In his spare time, Brown enjoys gardening, collecting Western antiques, fly fishing and cheering for his favorite sports team, the University of Wyoming Cowboys.

I have working knowledge of city affairs. I currently serve as the Director of Environmental Programs at Denver International Airport (DEN). My experience at DEN has given me a sound perspective in regards to the importance of the service levels provided by the Metro District and how these essential services help DEN to be America's favorite connecting hub, where the Rocky Mountains meet the world.

I have extensive experience as a water quality professional, and have contributed to scientific, engineering, regulatory, and policy aspects of sustainable water quality management strategies. My professional experience managing the water quality discharge permitting program for the State of Colorado provides me with working knowledge of challenges we face in balancing science, public policy, and technical and economic feasibility as we continue to move forward in growth while protecting our water resources.

My experience in civic engagement and leadership is extensive. I have served as staff to elected and appointed officials including members of legislative committees, boards and commissions, and local city council. I have contributed to program administration and facility operation in both state and local government. I have been asked to serve in a number of leadership positions in national associations and scientific research panels. I have been a long-time volunteer in my local community.

I stand ready to serve in this capacity to contribute the continuation of the Metro Districts outstanding level of service to its connectors and stewardship of water resources.

JANET KIELER, P.E. BIOGRAPHY

Janet is the Director of Environmental Programs for Denver International Airport (DEN). In this role she directs the work of environmental units, develops work plans and strategies for environmental performance, and resolves complex business issues. Janet is responsible for all aspects of environmental compliance and performance, including environmental planning and analysis, air quality, water quality, waste, wetlands, and endangered species. She designs and manages the programs, procedures, standards, and projects necessary to implement DEN's policies, goals, and objectives. Janet serves as a liaison and advisor to other groups at DEN providing programmatic support and subject matter expertise. Janet represents DEN in meetings with elected officials, appointed officials, other cities, and other agencies on environmental issues. In meeting DEN's environmental goals and objectives Janet manages an operating budget of \$5.5M that includes a staff of 13.

Janet served as the Permits Section Manager for the Water Quality Control Division of the Colorado Department of Public Health and Environment. In this role she was responsible for the issuance of NPDES and State permit actions, compliance aspects of several programs, data management, and business processes. The Colorado program is comprised of approximately 10,000 active permits associated with a variety of operations including with sewage systems, municipal separate storm sewer systems, mining, oil and gas exploration and development, construction, manufacturing, use of reclaimed water, land application of biosolids, and applications of pesticides. During her tenure Janet leveraged the program to develop a capacity to issue 5,000 permit actions per year and managed 30 staff.

In her role with the State of Colorado Janet chaired the permitting and compliance committee for the Association of Clean Water Administrators and represented states on a number of joint EPA-State work groups. Janet worked at a legislative level in regards to multiple issues related to formulating and implementing environmental programs and strategies. Janet engaged with high level officials and significantly contributed to the formulation regarding key policy aspects of the permit fee structure. In her capacity Janet provided oral testimony for legislative committees and the Water Quality Control Commission, facilitated stakeholder groups and public meetings, and navigated difficult situations to successful resolution.

Janet previously worked for DEN, managing many environmental aspects of airport operations. During this time Janet led the development of site-specific water quality standards for the receiving waters in the vicinity of the airport and her proposal won unanimous support by the Colorado Water Quality Control Commission. Janet was responsible for industrial stormwater permit compliance, management of contracted operations to recycle captured aircraft deicing fluid, and planning and designing new infrastructure to support collection, storage, recycling, and disposal of spent aircraft deicing fluid. Janet also managed a project conducted in close coordination with the Metro District to study options for enhanced disposal of spent aircraft deicing fluid which resulted in increased disposal at the Robert W. Hite Treatment Facility.

Janet also worked in private consulting, and supplements her water quality experience with work on a number of NEPA, air quality, CERCLA and engineering design and construction projects.

Janet is a registered professional engineer in the State of Colorado, and is a graduate of Northwestern University's McCormick School of Engineering and Applied Science. She has over 26 years of experience as an environmental professional. She is an active member of Airports Council International and currently chairs a project panel for the National Academies of Science, Engineering, and Medicine. She is a seasoned volunteer instructor with the National Sports Center for the Disabled and regularly contributes through her volunteerism to the mission of Special Olympics Colorado.
