8 For an ordinance authorizing the redistribution of funds from the Police Department's  
9 Victim Assistance Municipal Surcharge Special Revenue Fund to the Victim  
10 Assistance Municipal Surcharge Special Revenue Funds of the District Attorney, City  
11 Attorney and County Court.

13 WHEREAS, the Denver Revised Municipal Code, in Article VI, Section 20-101 through 20-  
14 106, as it may be amended from time to time, provides for the imposition, collection and  
15 distribution of an assessment on certain municipal ordinance violations, to be used for a Denver  
16 Victim Assistance and Law Enforcement (VALE) program; and

17 WHEREAS, the City and County of Denver has established special revenue funds for the  
18 receipt and disbursement of said funds by the Police Department, District Attorney, City Attorney,  
19 and the Denver County court; and

20 WHEREAS, the Police Department has a reserve of \$255,000 that the City desires to  
21 redistribute among the other three entities;

22 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF  
23 DENVER:

24 Section 1. There is hereby authorized the transfer of cash within the Public Safety Special  
25 Revenue Fund, Accounting No. 12000, in the amounts indicated in the following tabulation:
