A BILL

For an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and Living Cities/Bloomberg Philanthropies concerning the "Financial Empowerment Centers" program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, between Living Cities/Bloomberg Philanthropies and the City and County of Denver, which is identified as Grant No. 13-83-71-G-447, a copy of which is duly filed with the City Clerk, Filing No. 12-0989, be and hereby is approved in all respects.

Section 2. The payments made by Living Cities/Bloomberg Philanthropies to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Financial Empowerment Centers" Program, Accounting No. 11605-0150101-M4033 is as follows, to be expended by the Human Rights and Community Partnerships Director:

Living Cities/Bloomberg Philanthropies \$ 597,000

Authorization for expenditure of said funds following execution of said grant will cover the period from November 26, 2012 to November 26, 2015.

1 **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be
3 necessary to accomplish the purposes of this Ordinance.
