However, nothing contained herein shall preclude the Design Consultant from completing any task order authorized prior to the expiration of this Agreement and the Agreement shall be extended until the completion of and payment for all such authorized tasks."
- 2. As herein amended, the Agreement is affirmed and ratified in each and every particular.
