5 **A BILL**

6 **For an ordinance making a rescission from and an appropriation in the**
7 **“Denver Public Library” Fund, to make a cash transfer to and appropriations**
8 **in the “Library Capital” Fund; and authorizing the purchase of capital**
9 **equipment.**

10 **WHEREAS**, in the Denver General Election in November 2022, Denver voters approved
11 Referred Measure 2I to increase the City’s mill levy rate by 1.5 mills starting January 1, 2023,
12 which will provide additional funding for the Denver Public Library to maintain existing services and
13 meet the increased demand for additional services; and

14 **WHEREAS**, per the approved Measure 2I the Denver Public Library will receive property tax
15 revenue to fund library services, per article XVIII of Chapter 53 of the DRMC; and

16 **WHEREAS**, Ordinance 1596, series of 2022, created a Special Revenue Fund to receive
17 the additional mill levy revenue and administer current and expanded services; and

18 **WHEREAS**, companion Ordinance 0136, series of 2023, has been submitted to create the
19 “Library Capital” Fund (34041); and

20 **WHEREAS**, the City wishes to reallocate funds from the “Denver Public Library Fund”,
21 Accounting No. 15830, to the “Library Capital” Fund, Accounting 34041, and seeks approval for the
22 purchase of capital equipment;

25 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

28 **Section 1.** From appropriations heretofore made from the Denver Public Library Special
29 Revenue Fund, Accounting 15830, listed or indicated in the following tabulation there is hereby
30 RESCINDED the amount listed or indicated in such tabulation under the heading "Amount
31 Rescinded":

15 designated the amount of money, following such designation, to be expended for the purposes and
16 upon the authorizations in said Ordinance set forth:
