Approves a contract with Cutler Repaving, Inc. for \$4,288,898.50 and for 180 days for the 2021 Citywide Hot-In-Place Recycling and Repaving program (202157389).
Dedicates a parcel of land as public right of way as public alley, bounded by East 14th Avenue, North Trenton Street, East Colfax Avenue, and North Tamarac Street and dedicates a parcel of land as public right of way as East Colfax Avenue, located at the intersection of North Trenton Street and East Colfax Avenue in Council District 5.
