A BILL

For an ordinance authorizing the rescission and expenditure authorizations in the Environmental Services Enterprise Fund.

WHEREAS, The Department of Finance is requesting to rescind and reappropriate funds within the Environmental Services Enterprise Fund to address the costs associated with the W. Dakota Avenue Storm Water Outfall and Street Improvements Project; and

WHEREAS, Companion ordinances have also been submitted, including approving the agreement between the City, The Denver Urban Renewal Authority (DURA), and Broadway Market Place Metropolitan District #1 (BMP);

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

From appropriations heretofore made from the Environmental Services Enterprise Fund, Accounting No. 78000 listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the Environmental Services Enterprise Fund:
