CHaRTS III is a program with supportive case management for individuals residing in the Transitional Residential Treatment (TRT) Program, a 90-day transitional residential treatment program. Additionally, supportive case management will be provided for individuals in supportive or independent housing. Supportive housing is provided through U.S. Department of Housing and Urban Development (HUD) vouchers managed in partnership with the Colorado Coalition for the Homeless and DHS. A full-time case coordinator assists participants in CHaRTS III to transition from the detox unit, through transitional residential treatment, and into supportive or independent housing.
