I have been responsible for with both business and community relations. Involved in many negotiations and disputes. I have successfully resolved issues through discussion & compromise, arbitration and even litigation when forced.

Shortly after graduating from Colorado State I became an active member in with Sigma Phi Epsilon Alumni Corporation and became President in 1983. LDDI is a membership organization that supports Lower Downtown (LoDo) Denver's, unique historical, cultural and retail neighborhood, through marketing, education and advocacy.

I have been a sponsor of "ROJO CELIA" the Museo de las Americas' annual fundraising gala. Funds from this event allow the Museo to continue to bring unique exhibitions, programs and events to Denver that celebrate the art and culture of the Americas.

The council is advisory group that markets theater productions, programs, and develops strategic relationships.


