I. DEPARTMENTAL MATTERS IN THE REGULAR COURSE OF BUSINESS:

A. City Council - Councilwoman Debbie Ortega

BR13-0501 Councilmember Ortega – Amend Chapter 48 (Solid Waste) of the Revised Municipal 6 Code to add an Article IX (Disposable Bag Fees).

B. Community Planning and Development - Steven Chester/Olga Mikhailova

BR13-0588 Approves a no-cost, 7-month extension of the contract with Design Workshop for the completion of the Decatur-Federal Station/Sun Valley Area Plan and General Development Plan, which are to be completed by January 31, 2014, in Council District 9. (CPLAN201103318-00).

BR13-0590 Amends the 1999 R-X Development Plan for The Bluffs at Pinehurst to slightly modify the shape of and distance between the remaining 7 buildings, with no change to density or open space, in Council District 2.

C. Denver International Airport - Amy Raaz

BR13-0592 Approves a Lease Agreement with British Airways, PLC through 2016 for the right to use Denver International Airport's facilities to support their international flight operation (201310739).

BR13-0593 Approves a Lease Agreement with Prospect International Airlines Services, Inc. for \$5,709.60 annually to provide Denver International Airport's airlines with wheel chair services (201309825).

D. Public Works - Nancy Kuhn/Jim Barwick

RR13-0600 Grants a revocable permit to Denver Public Schools to encroach into a 0.12-acre portion of public right-of-way of S. Hooker Street at vacated W. Tennessee with synthetic turf field related construction at 911 S. Hazel Court, Kepner Middle School, in Council District 3.

BR13-0601 Vacates a small portion of the public right-of-way on W. Florida at S. Lipan, with reservations, for parking in Council District 7.

BR13-0602 Amends the contract with Greenwood Village for Belleview Concrete Repair and Pavement Rehabilitation by adding \$33,510.70, bringing the total to \$521,868.25.

BR13-0603 Approves an Intergovernmental Agreement with the Colorado Department of Transportation specifying conditions and responsibilities for the \$103,000,000 U.S. 6 Bridges Project, which will reconstruct US 6 between I-25 and Knox in Council Districts 3 and 9.

BR13-0604 Approves an Intergovernmental Agreement with the University of Colorado Denver to provide student interns on an on-call basis for work in the Public Works Department Engineering Division.

BR13-0605 Amends Section 1 of Ordinance No. 376, Series 2013, approving a contract with Trans-West Truck, Inc. to correct the Purchase Order Number to read PWOPS0000008600.

BR13-0598 Approves a \$1,500,000 master purchase order for Self Contained Breathing Apparatus for the Denver Fire Department (SCBA_EQUIP_DFD_0628A0112).
