The roles and responsibilities of the Denver Office of Cultural Affairs (01010-0116000) will move to the Theatres and Arenas Special Revenue Fund (15815-3050000) as of April 1, 2011. As a result, the budget will be rescinded from the General Fund and appropriations will be approved in Theatres and Arenas SRF in the approximate amount of \$959,500.
