5 **A BILL**

6 **For an ordinance making rescissions, cash transfers, and supplemental**  
7 **appropriations from the General Fund to Capital Improvement Project Funds.**

9 **WHEREAS**, the Department of Public Works, General Services, the City Attorney’s Office,  
10 and the Department of Finance have assessed current needs and available capacity in their  
11 respective 2018 General Fund appropriations; and

12 **WHEREAS**, said departments wish to re-invest operating dollars to support capital  
13 improvements including electric vehicle infrastructure, ADA-compliant restrooms at the Asphalt  
14 Plant, elevator repair at the Minoru-Yasui Building, office expansions and renovations at the City  
15 Attorney’s Office, and an evaluation to ensure ADA-compliance for existing and new assets;

17 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
18 **DENVER:**

20 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in  
21 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
22 under the heading "Amount Rescinded" and transferred to the General Fund:
