

# OPTION ALLOCATION LETTER

TO: City and County of Denver, a municipal corporation organized pursuant to the Constitution of the State of Colorado to be administered by the Department of Safety/Community Corrections Division.

In accordance with Section 7.A of the Original Contract between the State of Colorado, Division of Criminal Justice, Community Corrections, and City and County of Denver, a municipal corporation organized pursuant to the Constitution of the State of Colorado to be administered by the Department of Safety/Community Corrections Division beginning July 1, 2021 and ending on June 30, 2022, the undersigned commits the following funds to the Grant:

1. Payment for the period July 1, 2021 through June 30, 2022, will be made as earned, in whole or in part, from available State funds encumbered in an amount not to exceed **\$14,607,564.90** to be allocated as follows:

**\$8,810,209.40** for Residential services for community corrections offenders, payable at a daily community rate of \$49.16 per offender; (489 beds) and (2 Condition of Probation IRT base beds) and,

**\$ 339,815.00** for Non-Residential Diversion services for offenders not to exceed an average of \$6.65 per day per offender; (140 Slots) and,

**\$ 3,192,041.80** for enumerated below, payable at a daily community rate per offender;

- a) Service: Mental Health Services Differential  
Daily Rate per Offender \$34.70@40 for a total of \$506,620.00
- b) Service: TC Outpatient  
Daily Rate per Offender \$23.86@62 for a total of \$539,951.80
- c) Service: TC Residential Differential  
Daily Rate per Offender \$32.98 @108 for a total of \$1,300,071.60
- e) Service: CBT Differential \$52.64 @44 for a total of \$845,398.40

**\$ 679,000.00** Treatment Support Services and;

**\$ 150,000.00** CBT Specialized Offender Services and;

**\$ 940,570.97** for Facility Payments (7) to be disbursed as outlined in Statewide Facility Payment Policy for FY 22 and;

**\$ 495,927.73** for Community Corrections Board Administration by the Contractor.

2. Financial obligations of the State of Colorado payable after the current fiscal year are

contingent upon funds for that purpose being appropriated, budgeted and otherwise made available.

3. Funds allocated in this Allocation Letter are for services rendered during the current contract period and cannot be used to pay for community corrections services provided in prior or future fiscal years.
4. Any unexpended funds allocated or advanced to the Contractor by the Allocation Letter shall be reverted to the State no later than August 31, 2022.

This Allocation Letter does not constitute an order for services under this Grant. The effective date of hereof is upon approval of the State Controller or July 1, 2021, whichever is later.
